1. Introduction

Your privacy is important to me. This Privacy Policy explains how I collect, use, store, and protect your personal information when you visit my website or engage my services. By using this website, you agree to the practices described below.

2. Who I Am

I am Hannah Airey, a holistic wellness practitioner and workshop facilitator based in Christchurch, New Zealand, offering in-person healing services.

3. What Information I Collect

I may collect the following personal information:

Contact details — your name and email address when you fill out a contact form

Booking and appointment details — information provided when scheduling treatments or workshops

Health history information — relevant health background collected prior to treatments to ensure your safety and wellbeing

Newsletter signups — your name and email address if you choose to subscribe

Payment information — billing details collected when you pay for services or workshops

Scan information — scan results kept on Energy4Life secure health platform

4. How I Use Your Information

Your information is used to:

Respond to your enquiries and communicate with you

Schedule and manage appointments and workshop bookings

Provide safe and appropriate holistic treatments based on your health history

Send newsletters or updates (only if you have opted in)

Process payments securely

Comply with any legal obligations

5. Health Information

Health history information is treated with the utmost care and confidentiality. It is collected solely for the purpose of providing you with safe and appropriate care, and will never be shared with third parties without your explicit consent, except where required by law.

6. How I Store and Protect Your Information

Your personal information is stored securely and I take reasonable steps to protect it from unauthorised access, loss, or misuse. Payment information is processed through secure third-party payment providers and I do not store your full payment details.

7. Sharing Your Information

I do not sell, trade, or rent your personal information to third parties. Information may be shared only in the following circumstances:

With trusted service providers who assist in running this website (such as Wix)

With payment processors to complete transactions

Where required by New Zealand law

This website and its services comply with the **New Zealand Privacy Act 2020**. You have the right to access, correct, or request deletion of any personal information I hold about you. To make a request, please contact me directly.
